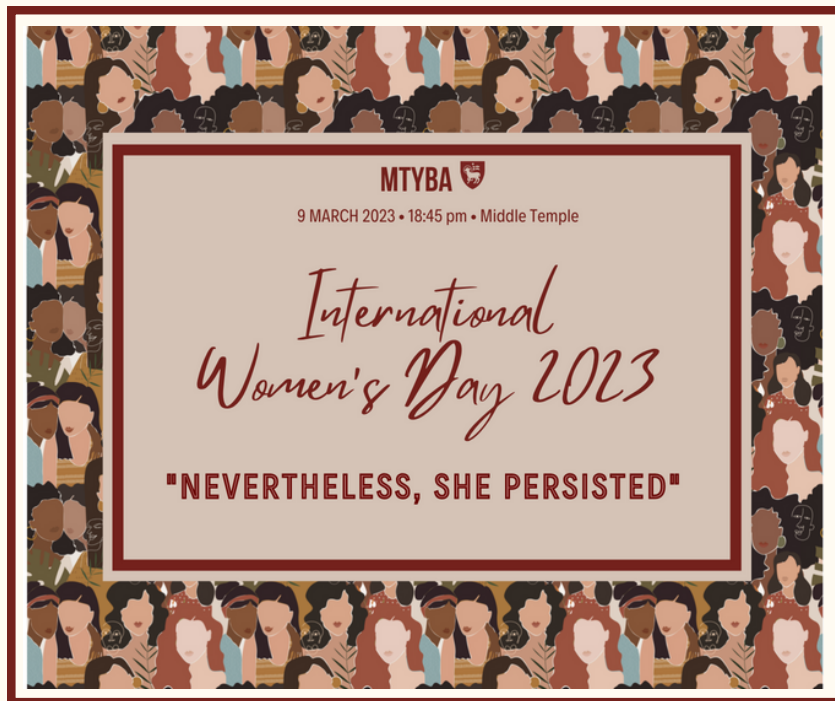
I look forward to meeting as many of you as possible at the Inn when we are able get together."
